

Capital Campaign




Announcing a Generous Gift from the Sunderland Foundation

The Sunderland Foundation is providing a \$1 million donation to the Kansas Museum of History capital campaign. The Sunderland family's roots extend far into Kansas history. In 1882 the family founded Ash Grove White Lime Association in Ash Grove, Missouri. The company took over a plant in Chanute, Kansas, in 1908. The Ash Grove Cement Company materials were used to construct highways, bridges, commercial and industrial complexes, and single- and multi-family homes. Through four generations of the Sunderland family, between 1909 and 2018, the company grew to become the fifth largest manufacturer of Portland cement in the United States, the sixth largest in North America.

Lester T Sunderland created the family foundation in 1945. The Sunderland Foundation, based in Overland Park, has invested in places and spaces where nonprofits do their work, including capital improvement and one-time special projects in the areas of arts and culture and education. The foundation's focus on funding has helped nonprofits fulfill their missions and foster stronger, safer, and more vibrant communities. His two sons, Paul Sunderland and Allen B. Sunderland, carried on his philanthropy.

"We are excited to leave this important legacy for future generations of Kansans," said Kent Sunderland, president of the Sunderland Foundation. "This innovative project will help students be proud of their state's role in the nation."





New Endowment for Hollenberg Pony Express Station

Margie Jaedicke, of Sequim, Washington, provided a generous donation of \$25,000 to create an endowment fund in the name of her father, August Jaedicke, Jr., for the preservation of the Hollenberg Pony Express Station State Historic Site near Hanover in Washington County. Gerat Hollenberg built the station in 1857, which he and his wife Sophia Hollenberg operated. They provided meals, supplies, and lodging for wagons on the Oregon-California Trail. Their ranch served as a way station for the Pony Express before Hanover was founded by Gerat Hollenberg in 1869.

August Jaedicke, Jr., was born in Hanover in 1871, the son of a young German emigrant, who helped found Hanover. With a strong interest in the Pony Express, he helped promote and preserve this unique historic site. From 1911-1914 he served as regional chairman to erect a large granite monument marking the Oregon Trail along the Kansas and Nebraska line. The monument was relocated west of Lanham, Nebraska, in 1993. Hollenberg Pony Express Station was purchased by the state of Kansas in 1941 to be preserved for future generations.

Mission

To support and promote Kansas history through the works of the Kansas Historical Society, a state agency.

Lisa Satterthwaite worked over the summer in 2018 and Justin Snyder over the summer in 2019. The Marylouise Meder Endowed fund provides for interns at the State Archives. McKenna Folster worked over the summer in 2019.

To connect people more closely with the Kansas Historical Society's programs

Nearly 1,700 members receive two quarterly magazines: *Kansas History, A Journal of the Central Plains*, an academic journal with peer reviewed new research, and quarterly issues of *Your Stories. Our History*, that included story cards and prompts. A number of members responded, sharing their own stories in Kansas history. Coming in fiscal year 2020 will be *Our Kansas Stories*, a look at times when Kansas history impacted the nation.

To extend the learning experience through shopping

Hazel Hill Chocolates, which recently received the Topeka Capital City Business of Distinction Award, has also been recognized internationally. Their chocolate is a bestseller in the Museum Store and Capitol Store.

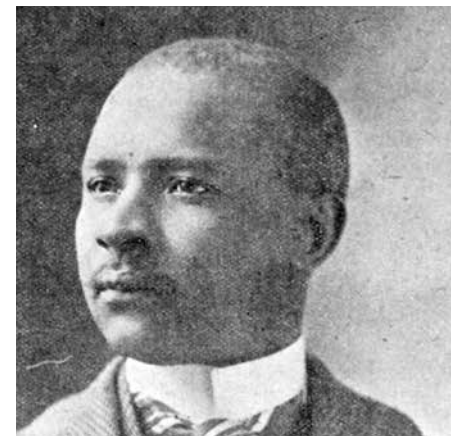

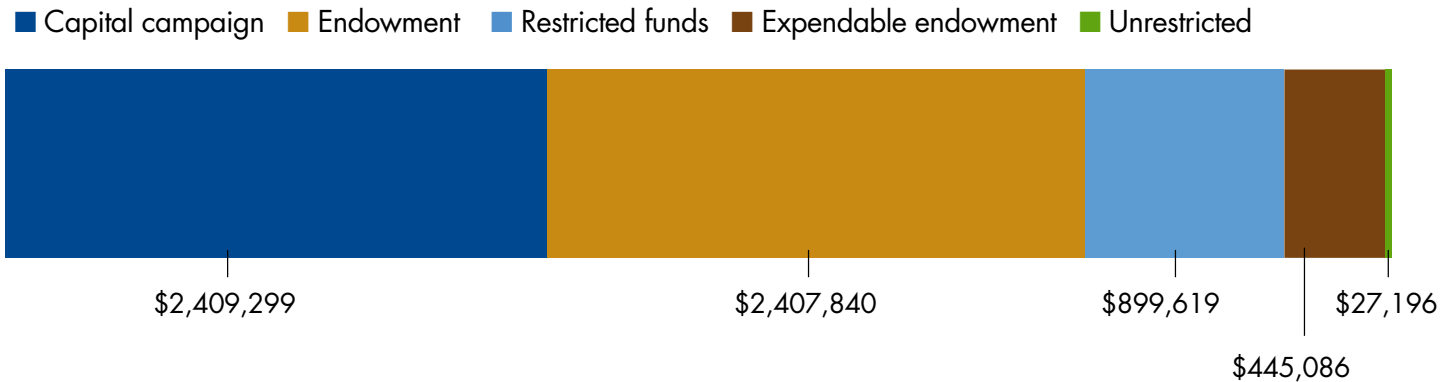

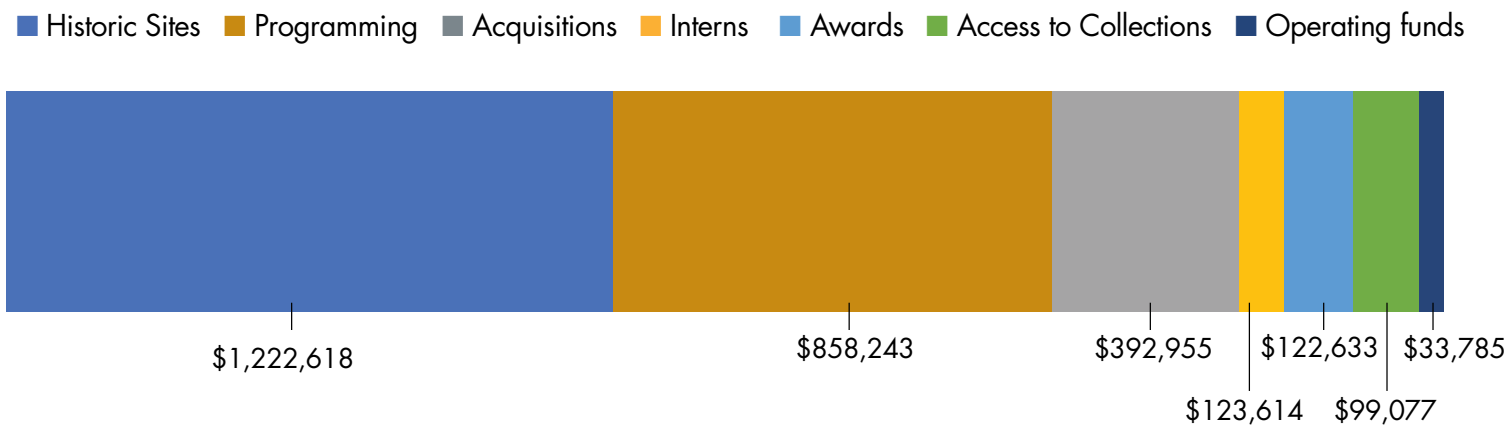
FY 2019 Assets
