Describe present and historic physical appearance.

The Council Grove United States Post Office (c. 1938-1939) is located at 103 West Main Street in Council Grove, Morris County, Kansas (pop. 2,381). The one story, flat roofed red brick and limestone building has a northwestern facade orientation. The building measures approximately sixty-four feet from southeast to northwest and fifty-five feet from northeast to southwest. A double door surmounted by a transom pierces the center of the building's facade. Steps lead up to the doorway. Two sets of large, multi-paned windows flank the doorway. Limestone panels surround the windows and the door on the facade, supporting a limestone stringcourse and concluding in the limestone foundation. Five windows of similar design pierce the east and west elevations of the building. This post office appears to be an example of a class B post office, rather than the more common class C or D type that was constructed in Kansas during the 1930s and 1940s.

The mural "Autumn Colors" was installed on the west wall of the Council Grove Post Office lobby above the postmaster's door and the two bulletin boards which flank it. This is the traditional location for Section artwork in the smaller post offices. "Autumn Colors" is a poppy seed oil on canvas mural that depicts a late fall scene of a farmstead in the Flint Hills near Council Grove. Minty green winter wheat sprouts cover the rolling fields around the farm. Bare and gnarled cottonwood trees dot the landscape. The white farmhouse, the several red barns, and grey sheds and outhouses all stand nestled against the rolling hills. A grey and cloudy sky rumbles on the horizon. The undulation of the hills, the various color patches of minty green and yellow green fields, the grey sky and trees, and the blue hills on the horizon make the landscape slightly scattered and hurried. Perhaps it is the early morning chill on a fall day that Rogers has captured.

The mural was installed in late May or very early April, 1941 and measured 14'3" by 6'3" before installation. A cornice surmounts the picture. Rogers wrote that he "believed the most satisfactory method of preserving the mural will be to give it a thin coat of pure mastic varnish during 1941 and at any future time that it may need it for restoration. Each coat will, after the pigment has been wiped clear of dust, rejuvenate that below. This procedure will protect the work for many years in

the dry climate of Kansas without further action." In 1966 the window and letter drop wall in the lobby was pushed forward approximately 7.5", covering over 7.5" on the left side of the mural, partially obscuring Rogers' signature. Rogers resigned the mural in May, 1980. In August, 1973 the mural's condition was assessed as good and remains as such.

A varnished, wooden vestibule projects into the lobby, cutting off some view of the mural. This is a tradition design feature found in most of the post offices included in this nomination. The floors and the wainscoting retain their original tiles. The postmaster's door and bulletin boards retain their varnished wood surrounds. The original five bronze lights that hung from the lobby ceiling have been replaced with almost flush mounted fluorescent lights.

State significance of property, and justify criteria, criteria considerations, and areas and periods of significance noted above.

The Council Grove United States Post Office (c. 1938-1939) is being nominated to the National Register as part of the Kansas Post Office Artwork (1936-1942) Thematic Resources nomination at the local and state levels of significance under criteria A and C for its historical association with the Treasury Department's Section program and for the artistic significance of the mural that it contains. The mural, "Autumn Colors" was painted by Great Bend, Kansas artist Charles B. Rogers (1911-1987) in 1941. Because the mural is less than fifty years old, criteria consideration G, which allows for exceptional significance in the case of properties achieving significance within the past fifty years, is also a factor. The National Register has identified post offices containing Section artwork as being exceptionally significant if they retain integrity from their period of significance.

"Autumn Colors" is a poppy seed oil on canvas mural that depicts a late fall scene of a farmstead in the Flint Hills near Council Grove. Minty green winter sprouts cover the rolling fields around the farm. Bare and gnarled cottonwood trees dot the landscape. Although this is a rural scene it is not peaceful, the undulation of the hills, the various color patches of minty green and yellow green fields, the grey sky and trees, and the blue hills on the horizon make the landscape slightly scattered and hurried. Perhaps it is the chill of the early morning on a fall day that Rogers has captured. "Autumn Colors" shows a place common to those familiar with the surrounding countryside. The landscape "Autumn Colors" is representative of the illustrative realism funded under the Section program. While the subject material and presentation of illustrative realism may make less of a social statement than social realism, illustrative realism still presents effective and valid views of America.

Rogers was a self-taught artist who studied under Birger Sandzen at Bethany College in Lindsborg, Kansas, graduating with a B.A. in 1942. He went on to take his M.F.A. at the California College of Arts and Crafts and then returned to teach at Bethany College through the mid-1950s. He later managed the Huntington Hartford Foundation and headed up the School for Art at Kansas Wesleyan University before opening up a gallery in Ellsworth, Kansas which he operated until his death in 1987. He received the commission for the Council Grove Post Office while a student at Bethany College in 1940. Initially, he had entered the competition for the St. Louis Post Office, winning an honorable mention.

The honorable mention in the larger competition facilitated the awarding of the smaller Council Grove contract, a scenario that was repeated frequently during the Section program. Of the commission Rogers said during a 1964 interview that "(t)his is the strangest thing about the business of having been put on the Project, that not only was I in an insulated area there, young and self-taught on top of that, but this was strictly brought about by others. There were no organizations, for that matter, no art where I grew up. I saw my first original paintings when I was fairly grown up."

Community involvement in the development of the subject material and presentation of the mural was not extensive. When Rogers approached the postmaster initially about taking lobby measurements for the mural, the postmaster angrily told him that the post office did not want a mural. Rogers did not return to the Council Grove Post Office to install the mural once it was completed, but instead hired "two big Swedes" from Lindsborg, one of whom was Ernest K. Peterson, to attach the mural to the wall with white lead. Of the mural the Council Grove Republican wrote "(s)everal persons have expressed their satisfaction while a number of others have said that they did not feel the work properly depicted the Flint Hills farm scene."

Rogers received the commission on April 15, 1940 and the mural was installed in late May or very early April, 1941. The mural measured 14'3" by 6'8" before installation and was installed on the west wall of the Council Grove Post Office lobby, above the postmaster's door and the two bulletin boards that flank it. Rogers received \$800 for the commission. In 1966 the window and letter drop wall in the lobby was pushed forward

approximately 7.5", covering over 7.5" on the left side of the mural, partially obscuring Rogers' signature. Rogers resigned the mural in May, 1980. The Council Grove Post Office is an example of a class B post office that received Section artwork in Kansas.
